

Announcement of the Faculty of Pharmacy, Mahidol University Re: Admission Selection for Doctor of Pharmacy (International Program) through the Faculty's Direct Admission System, Academic Year 2026 (2569 B.E.)

The Faculty of Pharmacy, Mahidol University, intends to recruit and select individuals for the Doctor of Pharmacy (International Program) direct admission system for the Academic Year 2026 (2569 B.E.) The Faculty has therefore established the following admission criteria:

1. The total admission is 45 students (or individuals/persons).

#### 2. Applicant Qualifications

- 2.1 General Oualifications
  - 2.1.1 Must be at least 16 years of age as of the first day of the first semester of Academic Year 2026 (2569 B.E.).
  - 2.1.2 Non-Thai applicants are responsible for obtaining the necessary visa to enter Thailand for the interview and physical examination by the date and time specified by the Faculty of Pharmacy.
  - 2.1.3 Must not be currently studying for a Doctor of Pharmacy degree at any other public institution, unless they have resigned before the application date.
  - 2.1.4 Must not have the right to enroll or have already confirmed their enrollment in the Thai University Central Admission System (TCAS) for the Academic Year 2026 (2569 B.E.) with any institution. The University will check the enrollment confirmation status in the system of the Council of University Presidents of Thailand (CUPI).
  - 2.1.5 Must have good conduct and certify to Mahidol University that they will study diligently to the best of their ability and strictly comply with the existing and/or future regulations of Mahidol University.
  - 2.1.6 Must have a guarantor who will be responsible for all tuition and related expenses until the program completion.

/2.1.7 Must...

2.1.7 Must be physically and mentally healthy and free from diseases that pose an obstacle to studies, practical training, and the practice of pharmacy, including: psychiatric illnesses, contagious diseases in a dangerous stage, deafness, or muteness. A medical certificate must be submitted for confirmation. This also includes other diseases or disabilities not specified but deemed by the Subcommittee for the Selection of Individuals for the Doctor of Pharmacy (International Program) Direct Admission System to be a potential obstacle to studies, practical training, and the practice of pharmacy.

Remarks: Successful applicants must submit a physical examination record form and the results of the physical examination as specified by the Faculty. Health problems or diseases under item 2.1.7 will be decided upon by the Subcommittee, and their decision is final.

## 2.2 Specific Qualifications

#### 2.2.1 Educational Qualifications

- 2.2.1.1 Must be currently studying or have completed Mathayom 6 (Grade 12) Science Mathematics track, or be currently studying or have completed studies from an International School (American System Grade 12 or British System Year 13), or be currently studying or have completed studies from an overseas school, in accordance with the equivalence criteria set by the Ministry of Education (MOE). regulations on the equivalence of domestic and international basic education 2020 (2563 B.E.).
- 2.2.1.2 Applicants must show grades in 3 out of 4 subjects from the Science Mathematics group (Chemistry, Biology, Physics, and/or Mathematics) on their Transcript. Furthermore, the grades in the subjects submitted must meet specific criteria: a cumulative subject GPA of 4.00 (A) in 1 subject and a cumulative subject GPA of 3.00 (≥B or higher) in 2 other subjects from the aforementioned group as shown in the transcript.

#### 2.2.2 Required Test Scores

2.2.2.1 Applicants currently studying in Mathayom 6 (M.6) and expected to graduate in Academic Year 2026 (2569 B.E.), or applicants currently studying in an international school (Grade 12, American System, OR Year 13, British System), must submit a cumulative Grade Point Average (GPA) for 4 semesters with a minimum cumulative GPA of 3.00 (Academic Year 2023 and 2024). OR Applicants who have already graduated from Upper Secondary School must submit a cumulative GPAX for the entire curriculum of 3.00 or higher.

2.2.2.2 Applicants who are currently studying or have completed studies from an International School (American System Grade 12 or British System Year 13) must submit an overall cumulative GPA of 3.00 or higher and either an IB Diploma score of 35 or more (out of 45) or an International A Level score of ABB or higher from 3 out of the 4 subjects in the Science–Mathematics group: (1) Chemistry, (2) Biology, (3) Physics, and/or (4) Mathematics.

Remarks: Applicants who have completed or are currently in the final year of high school in other educational systems may apply, subject to the discretion of the Subcommittee.

#### 2.3 Standardized Test Scores

Applicants are required to submit test scores for **two components**: The Standardized Test Score and the Standardized English Proficiency Test Score. The submitted test scores under Item 2.3 must be valid for a period not exceeding **two** years from the date of the result announcement until the date of the interview, as follows:

#### 2.3.1 Standardized Test Score

Applicants must submit the score from ONE of the following tests:

- Thai Biomedical Admissions Test (TBAT) OR
- Medical College Admission Test (MCAT) OR
- CU Aptitude Test for Science (CU-ATS) OR
- Other recognized standardized test scores or specialized science knowledge test scores only.

Remarks: The total score must be at least 50% of the maximum total score. The score must be valid for not more than 2 years from the test date until the interview date.

## 2.3.2 English Proficiency Test Scores

Applicants must submit one of the following English proficiency test scores. The score must be no more than two years from the date of the score announcement to the interview date:

- TOEFL Internet-based (TOEFL- iBT) with a score of at least 79 OR
- IELTS Academic Test with a score of at least 6.5

# 3. Admission for Bachelor's Degree Graduates

#### 3.1 Educational Qualifications

3.1.1 Must have completed a Bachelor's degree in a science-related field, such as Applied Science, Physics, Chemistry, Biology, Bachelor of Education (B.Ed.), Bachelor of Nursing Science (B.N.S.), Doctor of Veterinary Medicine (D.V.M.), Bachelor of Public Health (B.P.H.), Bachelor of Engineering (B.Eng.), or Bachelor of Science (B.Sc.).

/3.1.2 In the...

- 3.1.2 In the case of a Bachelor's degree with a qualification not listed in 3.1.1, the Faculty reserves the right to consider the application based on the facts, and the committee's decision shall be final.
- 3.1.3 Must be no older than 35 years as of the first day of the semester of application.
- 3.1.4 Must have a cumulative GPA of  $\geq$  3.25 for the entire Bachelor's program.
- 3.1.5 Must have a GPA of 3.00 (or B) or higher in the specific or compulsory subjects of the program (excluding elective courses) at the Bachelor's degree level.
- 3.1.6 Must have Standardized Test Scores as per item 2.3.

  Remarks: For applicants who have completed a Bachelor's degree, the decision on the selection results rests with the authority and discretion of the Subcommittee for the Academic Year 2026 (2569 B.E.), and their decision is final.

# 4. Application Process and Required Documents

- 4.1 Study the Details in the Application Announcement. (Applicants must study the information thoroughly for their own benefit.)
- 4.2 Apply through the online system at the website: http://10.8.51.1/admininter/mainmenu.php
- 4.3 Details for Uploading Supporting Application Documents are as follows:
  - 4.3.1 Applicant's Photograph Must be a single, front-facing photo, wearing a student uniform or smart attire (no hat or dark glasses), with a white or blue background. Size 1.5 x 2 inches, taken no more than 6 months prior, and must not be digitally altered. Scan as a JPEG file (.jpeg or .jpg). File size must not exceed 2 MB.
  - 4.3.2 Completed Application Form

    Fill in all required information completely. Sign with your full signature and printed name using a blue ink. Scan as a .pdf file. File size must not exceed 2 MB.
  - 4.3.3 Copy of National ID Card (Front side only) OR Copy of Passport Photocopy onto an A4-sized paper. The applicant must sign and write their full name to certify the true copy ("รับรองสำเนาถูกต้อง") using blue ink. Scan as a .pdf file. File size must not exceed 2 MB.
    - In case the applicant's name or surname on the National ID card or Passport does not match other evidence, attach photocopies of evidence of name and/or surname change on A4 paper. The applicant must sign and write their full name to certify the true copy with a blue ink pen and scan all related documents into a single .pdf file.
  - 4.3.4 Copy of House Registration (for Thai nationals) OR Copy of Residence Permit in Thailand (for foreign nationals) Photocopy onto A4-sized paper. The applicant must sign and write their full name to certify the true copy with a blue ink pen. Scan as a .pdf file. File size must not exceed 2 MB.

## 4.3.5 Educational Documents

Photocopy onto an A4-sized paper. The applicant must sign and write their full name to certify the true copy with a blue ink pen. Scan all documents into a single .pdf file. If a document has two sides, scan both the front and back. File size must not exceed 2 MB. The required documents are:

- A. Copy of certificate/diploma from the graduating institution or a letter certifying completion status in the academic year 2025 (2568 B.E.).
- B. For applicants studying under the IB Diploma and International A Level system, a letter showing the predicted IB Diploma or International A Level scores must be attached.
- C. Copy of Academic Transcript.
- 4.3.6 Standardized Test Scores As specified in Clause 2.3, this includes the Standardized Test Scores and the standard English proficiency test scores. Photocopy onto an A4-sized paper. The applicant must sign and write their full name to certify the true copy with a blue ink pen. Scan as a .pdf file (if a document has two sides, scan both the front and back). File size must not exceed 2 MB.

#### 4.3.7 Portfolio

- Select one of the following themes: 1) Academic, 2) Art, 3) Leadership, and 4) Social Responsibility.
- Present 2-3 activities/works under the chosen theme
- All information in the Portfolio must be presented in English only.
- Present activities/works in a portrait orientation, A4-sized page, with no animation, video, or QR codes. Save the file as a .pdf.
- The Portfolio must consist of a total of 5 pages:
  - Page 1: Information about the applicant, the chosen theme, and a brief explanation of the reason for choosing that theme.
  - Pages 2–5: Photos of the activities/works under the chosen theme, along with descriptions.
- 4.3.8 Statement of Purpose (SOP) Must be written in English. The content should explain the reasons and motivations for applying to the Doctor of Pharmacy Program (International Program), as well as life goals and aspirations.

#### Requirements:

- Content length must be between 500 800 words.
- Font style: Times New Roman.
- Font size: 12. Line spacing: single space.
- Save the file as a .pdf format. File size must not exceed 2 MB.

4.3.9 Proof of Application Fee Payment (3,400 Baht) The original deposit slip for the payment of the application fee, totaling 3,400 Baht (Three Thousand Four Hundred Baht only), received from the bank must be scanned as a .pdf file, and the file size must not exceed 2 MB. Alternatively, payment can be made via the bank's online service, ensuring that the depositor's name is specified as the applicant's name. The program reserves the right not to refund the application fee under any circumstance. The applicant is responsible for any transfer fees or currency exchange rate differences. The application fee must be deposited according to the following details:

4.3.10 Health Examination Results Must be on the Faculty's form, which can be downloaded from the website: <a href="https://shorturl.asia/tq8Bm">https://shorturl.asia/tq8Bm</a>. Must be a medical certificate issued by a government or private hospital, as specified in Clause 2.1.7. Remarks: The applicant must bring the original copy of the health examination results (on the Faculty's form) to the interview date.

- 4.3.11 Letters of Recommendation from Two Teachers (1 letter from each teacher)
  - A. Content should include a recommendation of the applicant and their suitability for the Doctor of Pharmacy Program (International Program).
  - B. Must be typed in English or Thai, no longer than one A4 page, and stamped with the school's seal, and placed in a sealed envelope.

The applicant can submit the letters along with other application documents, or the teacher can send the document directly from the applicant's school to the Faculty of Pharmacy, Mahidol University.

- 4.4 Applicants must check the accuracy of all information in the application form within the system before clicking to confirm the application data. Once the application data has been confirmed, applicants must print the application form from the system and sign it with their full name. If data correction is needed, applicants must inform the Educational Affairs staff, Mahidol International Pharmacy School (Miss Parnphat), at the Faculty of Pharmacy, Mahidol University, by email: parnphat.gat@mahidol.ac.th, to request corrections only.
- 4.5 Submission of All Application Documents

The applicant must send all application documents to the Mahidol International Pharmacy School, Faculty of Pharmacy, Mahidol University, using Thailand Post or a private courier service. The documents must be submitted no later than Thursday, December 4, 2025 (2568 B.E.) at 16:00 (4:00 p.m.). The postmark date will be considered as the primary submission date.

#### Remarks:

- 1. The application process will be deemed complete only when the applicant has applied through the online system, paid the required application fee within the specified period, and the Faculty of Pharmacy, Mahidol University, has received all application documents. Should any step not be completed within the specified time, the applicant will not be able to claim any rights later, and the Faculty of Pharmacy will not refund the application fee or any other fees under any circumstances.
- 2. In the event of errors caused by the applicant, or if it is found that the applicant used counterfeit or false documents during the application, selection, or enrollment process, which are not in accordance with the application announcement, the applicant will be deemed to have failed to meet the application qualifications and the application will be considered null and void.

- 3. The Faculty of Pharmacy, Mahidol University, will retain applicant data for a period of 1 year and 6 months as per the data retention plan. This data will be used for statistical analysis and research, quality and process improvement, and for verifying application and enrollment evidence.
- 4. The consideration of eligible candidates for the interview and the pharmaceutical aptitude test is at the sole discretion of the Subcommittee for Examination Administration and shall be final.

#### 6. Admission and Selection Criteria

6.1 Academic Achievement	30%
6.2 Pharmacy Aptitude Test (Written Exam)	30%
6.3 Interview (English Interview)	30%
6.4 Portfolio and Statement of Purpose	10%

**Remarks:** The final decision on admission rests solely with the Admission Committee of the Doctor of Pharmacy Program.

## 7. Enrollment Confirmation Steps

Accepted applicants (both successful candidates and reserve candidates) must confirm their enrollment in a total of **2 steps** as follows:

## Step 1 Confirmation with the Faculty

- Accepted applicants, both Thai and non-Thai nationals, must confirm the enrollment at the Faculty of Pharmacy, Mahidol University at the given date and time.
- For Thai applicants who fail to confirm, the Faculty of Pharmacy will not submit their names to the TCAS Clearing House system (the schedule for the TCAS Clearing House system will be announced along with the list of accepted candidates). And

# Step 2 Confirmation in the TCAS System (For Thai Applicants Only)

- Thai accepted applicants must confirm their enrollment through the Clearing House system scheduled by TCAS at <a href="https://www.mytcas.com">www.mytcas.com</a>, by choosing only one qualified program/field of study.
- Failure to confirm eligibility within the specified period will be considered a waiver (renunciation of rights), and applicants cannot claim any rights later.

# 8. English Proficiency Standard for Graduation

Undergraduate students must pass an English proficiency test before graduation, following the conditions and criteria established by the university. This requirement is considered as one of the considerations for degree approval, in accordance with the Mahidol University Regulations on Diploma and Undergraduate Studies and the Mahidol University Announcement on English Competence Standards for Undergraduate Students of Mahidol University 2023(B.E. 2566), Announced on December 20, 2023(B.E. 2566).

## 9. English Proficiency Test

Mahidol University offers a MU-ELT English Language Proficiency Test at no cost for newly enrolled students, limited to one-time use. Detailed information regarding test scheduling and administration can be accessed through official announcements released. In addition, students who have already obtained English proficiency test scores, Mahidol University supports various recognized tests in accordance with its English Language Proficiency for Undergraduate Programs. As per the university's announcement for the academic year 2023(B.E. 2566), students are permitted to submit English proficiency test scores taken within two years prior to the commencement of the semester.
